MANITOBA STANDARD BRED FUTURITY #20 – PURSE \$10,000 ADDED

Sustaining payment of \$100.00 is due May 15, 2012 – for Manitoba foaled Standardbred fillies, colts and geldings of 2009 to race as three-year-olds in 2012.

Starting payment of \$250.00 is due at time of declaration.

MANITOBA STANDARD BRED FUTURITY #21 – PURSE \$10,000 ADDED

Sustaining payment of \$75.00 is due May 15, 2012 – for Manitoba foaled or sired Standardbred fillies, colts and geldings of 2010 to race as three-year-olds in 2013.

Sustaining payment of \$100.00 is due May 15, 2013.

Starting payment of \$250.00 is due at time of declaration.

MANITOBA STANDARD BRED FUTURITY #22 – PURSE \$10,000 ADDED

Sustaining payment of \$50.00 is due May 15, 2012 – for Manitoba foaled or sired Standardbred fillies, colts and geldings of 2011 to race as three-year-olds in 2014.

Sustaining payment of \$75.00 is due May 15, 2013.

Sustaining payment of \$100.00 is due May 15, 2014.

Starting payment of \$250.00 is due at time of declaration.

MANITOBA STANDARD BRED FUTURITY #23 – PURSE \$10,000 ADDED

Nomination payment of \$15.00 is due May 15, 2012 for Manitoba foaled or sired fillies, colts and geldings of 2012 to race as three-year-olds in 2015. Nomination fee is non-refundable and non-transferable.

Eligibility: Broodmare nominee(s) must be registered in the name(s) of Manitoba residents on or before May 15, 2012. Broodmare nominee(s) may also be leased 100% by a Manitoba resident(s) on or before May 15, 2012, but the lease must be registered with Standardbred Canada. Broodmare nominee(s) must foal in the province of Manitoba. OR Broodmare nominees must be in foal to/foal by a Manitoba sire.

Sustaining fee of \$50.00 is due May 15, 2013.

Sustaining fee of \$75.00 is due May 15, 2014.

Sustaining fee of \$100.00 is due May 15, 2015.

Starting payment of \$250.00 is due at time of declaration.

FOR ALL FUTURITIES:

1. Eliminations (60%) and a Final (40%) will be scheduled on separate dates as scheduling permits.

DECLARATION FEES to be wholly added to the Final.

2. Racing conditions of the MSSBA stakes will apply unless otherwise specified.

3. All nomination and sustaining fees must be postmarked no later than MIDNIGHT, May 15, 2012. It is recommended that forms be completed and returned with sufficient payment to the Manitoba Standardbred Sires and Breeders Association as early as possible in order to be processed and a receipt returned in due time. This will assist to alleviate any potential errors or omissions which may occur.
